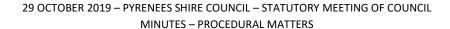

Highlights for me have been attending the National Roads and Infrastructure Conference in Alice Springs, the National Local Government Conference in Canberra, official opening of the Crowlands Wind Farm with a delegation of 24 people from China and visits to Ministers in State Government to advocate for projects for the betterment of our communities. I get a great deal of pleasure in networking with other local government leaders.

In the Mayoral role I get the opportunity to work with the community members directly and I thank them for the respect they have shown me in the role of Mayor. It is fair to say that things mostly travel well but not always. Councillors have the ability to close ranks, make their thoughts known respectfully and move on which makes the Mayor's role so much easier.

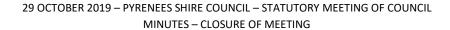
